



G7 Bars Meeting

Proposals to the G7 governments

1. We, the representatives of the bar associations in the G7 countries;
2. **Meeting** in Paris on July 11th and 12th, 2019 for the "G7 Bars Meeting";
3. **Reaffirm** the essential role of the legal profession in upholding the rule of law, access to justice and the fundamental principles of democracy, including the independence of the judiciary;
4. **Emphasise** the importance of respect for the rule of law to ensure the economic prosperity of our respective countries;
5. **Proclaim** our wish to engage in a constructive dialogue with governments and civil society organisations in order to find common solutions to the challenges the system of justice is facing, especially in relation to the protection of the rule of law and the independence of the system of justice;
6. **Recall** our dedication to human rights and commitment, to ensure that lawyers, judges and prosecutors are able to perform their duties without intimidation, harassment, or inappropriate interference ;
7. **Remind** governments of the vital importance of promoting and protecting the rights enshrined in the International Covenant on Civil and Political Rights and in the International Covenant on Economic, Social and Cultural Rights;
8. **Having considered** the priorities stated for the G7 Summit of Heads of State and of Government, to be held from the 24th to the 26th August in Biarritz, France;
9. **Request our respective governments** to consider the following proposals and recommendations:



Concerning the fight against inequalities and promoting Access to Justice:

10. Support the participation of bar associations, court systems, and others in activities that promote awareness of the system of justice and the rule of law from an early age by organising awareness days in schools with lawyers, judges, and other members of the legal profession explaining the importance of the rule of law and presenting the role of the legal profession in so doing and promoting access to justice ;
11. Promote gender and other equality in society and in the workplace, including the legal profession, by addressing conscious and unconscious bias, the gender pay gap, and other discrimination in pay, bullying and sexual harassment, in collaboration with legal professional bodies, relevant state authorities and civil society organisations;
12. Commit to including legal aid by independent lawyers as part of humanitarian aid;

13. Promote meaningful debate at an international level regarding the responsibility of governments to safeguard both the environment and the climate for current and future generations;

17. Ensure access to a counsel of one's own choosing, the confidentiality of the lawyer-client relationship, the right to prepare a defence, and the right to a fair trial and an independent judiciary;
